- 1. Town Administrator, Troy Brown, requested to add the Purchase and Sales Agreement of the parcel of land in the Town of Litchfield. The town's legal counsel has reviewed the Purchase and Sales Agreement. Town Administrator, T. Brown, wanted to discuss the subject and have the Board of Selectmen sign the Purchase and Sales Agreement. Signing the P & S Agreement will allow the town to move forward with the process of the title search and scheduling the closing.
- 2. Selectmen S. Webber suggested moving this subject to the Business portion of the meeting agenda.

#### Skid Steer Grant Acceptance - (\$5,000):

1. Dave Mellen came to the Board of Selectmen three months ago and requested permission to trade-in the skid steer. The belief was to turn in the skid steer while it still had a good trade in value.

- 2. Dave Mellen also requested permission to file for a grant to help with the purchase of a new skid steer.
- 3. The town purchased a new skid steer for \$35,000.
- 4. The town received a \$12,000 trade in value for the town's skid steer
- 5. The town received a grant for \$5,000. The \$5,000 is the maximum one could receive.
- 6. The total cost for the new skid steer was \$18,389. The purchase includes a five-year warranty.
- 7. The skid steer was purchased with a trade-in, a grant, and user fees. The purchase was funded out of the revolving funds.

#### **Review Fee Schedule Changes:**

- Dave Mellen approached Town Administrator, Troy Brown about considering revising or implementing some new fees.
- 2. Troy Brown sent a correspondence around to the department heads, to receive their input.
- 3. Town Administrator, Troy Brown will schedule a public hearing for Monday, April 8, 2019.
- 4. Transfer Station Fees:
  - a. <u>Tire Fee</u> The current fee is \$2, Dave Mellen is suggesting an increase to \$3.
  - b. <u>Mattress / Box Spring Fee</u> Litchfield currently does not have a fee. Other towns are charging \$40 per mattress or box spring. Dave Mellen is suggesting a \$15 fee.
  - c. <u>Toilet Fee</u> In the past, the toilets would be broken down and thrown into the glass recycling container. Porcelain no longer can be thrown into the glass recycling container. The toilets are thrown into the dumpster and brought to the landfill. A fee will be charged for throwing away toilets.
  - d. <u>Fire Extinguishers</u> Fire extinguishers are longer allowed to be disposed of. Dave Mellen is suggesting a fee of \$5 to cover his costs.
- 5. Town Clerk's Office Fees:
  - a. <u>Boat Agent Fee</u> The town does not have a fee listed, but the town charges \$5.
  - b. <u>Dredge and Fill Permit</u> The town does not have a fee listed, but the town charges \$10.
  - c. Poll Permit Fee The town does not have a fee listed, but the town charges \$10.
  - d. <u>Divorce Certified Copy Fee</u> The town does not have a fee listed, but the town charges \$15.
  - e. Certified Dog License Fee The town references May 31, the date has changed to July 15.
  - f. Convenience Fee A \$1 fee is charged to mail back a resident's car registration sticker.
- 6. Selectman K. Lynch asked if the porcelain toilets could be broken down and placed in the masonry container. Troy Brown will ask Dave Mellen if this is an option.
- 7. The last time the fees were updated was three years ago.

#### **Eversource Energy:**

- Eversource Energy, formerly PSNH, filed a tax abatement appeal.
  - a. They have filed the tax abatement appeal with almost every town and city in New Hampshire.

- 2. Eversource Energy is filing this appeal going back to the year 2014 and every tax year after 2014.
- 3. The basis of the tax appeal is Eversource Energy believing that the towns and cities of New Hampshire don't have the right to tax Eversource for the use of the right of ways to place their poles and conduits.
- 4. The Board of Selectmen previously agreed the Town of Litchfield would join legal efforts with about 43 other towns legal counsel.
- 5. George E. Sansoucy, P.E., LLC. provides utility appraisals and engineering services. Sansoucy will be representing as the technical advisors for the 43 other towns as well.
- 6. A hearing is scheduled for November 5, 2019. The Board of Selectmen are skeptical that the hearing will occur. The board believes this will drag out for years.
